**56th ANNUAL WATER SUPPLY AND POLLUTION CONTROL SHORT COURSE
MISSISSIPPI STATE UNIVERSITY, STARKVILLE, MS
MAY 24-28, 2010**

The 56th Annual Water Supply and Pollution Control Short Course is scheduled at Mississippi State University, Starkville, Mississippi, May 24-28, 2010. **Registration will be held in McCain Hall** on Monday, May 24 from 7:30 - 8:30 a.m. for persons attending certification classes. Certification classes will start at 8:00 AM and dismiss at 5:00 PM each day. Instruction will be offered for B, C, and D water supply operators and for Class I, II, III, and IV pollution control operators. **ALL Persons attending water certification classes MUST bring a chlorine test kit.**

Registration for the CEU class will be held at 7:30 AM on Tuesday. **The CEU Class will begin at 8:00 A.M. on Tuesday and finish at 5:00 P.M. on Wednesday for a total of 16 hours.**

Certifying examinations for all classes in both water supply and pollution control will be held Friday morning, May 28, 2010, at 8:00 a.m. **ANYONE DESIRING TO TAKE A CLASS I OR II WASTEWATER EXAMINATION MAY DO SO WITHOUT PRIOR NOTICE AND WITHOUT BEING REGISTERED FOR THE SHORT COURSE. PERSONS DESIRING TO TAKE A CLASS III OR IV WASTEWATER EXAM MUST HAVE TAKEN AND PASSED A CLASS II EXAM PRIOR TO ATTEMPTING THE CLASS III OR IV. YOU MUST HAVE ATTENDED A WATER SUPPLY SHORT COURSE (CLASS A-D) WITHIN THE PAST 12 MONTHS IN ORDER TO BE ELIGIBLE TO TAKE A WATER SUPPLY TEST. THERE WILL BE A \$35.00 TESTING FEE CHARGED FOR TAKING AN EXAM.** You may pay the fee with your registration for the short course or if you do not plan to take the course but would like to take an exam, you can pre-register for the exam and pay the testing fee. All classes and exams will be held in Carpenter Hall and McCain Hall. Water Manuals - \$35.00 (1998 edition) and Wastewater Manuals - \$50.00 (2008 edition) will be available for purchase at registration as usual.

Pre-registration fee for the certification classes (B, C, D or I, II, III, IV) for members of the Mississippi Water and Pollution Control Operators' Association, Inc. is \$200 and \$350.00 for non-members. Pre-registration fee for the CEU classes (water or wastewater) is \$150 for members and \$300 for non-members. These fees cover the cost of supplies, one ticket to the BBQ lunch on Tuesday (tickets for the lunch will be \$15.00 for those not registered for the short course), and services related to the short course. The registration fee does not include manual fee, testing fee or expenses for lodging or meals.
