The 32nd Annual Central Mississippi MWPCOA Short Course is scheduled at the Clyde Muse Center of the Rankin Campus of Hinds Community College, Pearl, MS the week of February 11-15, 2019. All classes will be held in the Muse Center. **All attendees for WASTEWATER CERTIFICATION are highly encouraged to register early and order a manual to study prior to the course.** Wastewater Manuals - \$50.00 (2007 edition) will be available for purchase at registration if not purchased in advance. Those attending the certification short course are required to bring calculators. **WATER SUPPLY CERTIFICATION CLASSES A, B, C AND D WILL NOT BE OFFERED AT THIS SHORT COURSE. CONTACT MSDH AT 601-576-7518 FOR WATER CERTIFICATION SCHEDULE.**

Instruction will be offered for Class I, II, III and IV pollution control operators from 8AM to 5PM, Monday through Thursday, and testing on Friday.

CEU classes for certified water and wastewater operators will begin at 8:00 A.M. on TUESDAY and finish at 5:00 P.M. on WEDNESDAY for a total of 16 hours in WATER (8 MSDH Regs + 8 Non-Regs) OR 16 MDEQ SPONSORED WASTEWATER HOURS. Please mark the appropriate class on the attached pre-registration form.

Certifying examinations for all classes in pollution control (I-IV, CSI, CSII) will be offered Friday morning, February 15, 2019, beginning at 8:00 a.m. **YOU MUST PRE-REGISTER TO TAKE AN EXAM. THERE WILL BE A \$40.00 TESTING FEE CHARGED FOR EACH TEST TAKEN. PERSONS ARRIVING AFTER 8:00 A.M. WILL NOT BE ALLOWED TO TAKE A TEST. COLLECTION SYSTEM COURSE WILL NOT BE OFFERED AT THIS SHORT COURSE. ANYONE DESIRING TO TAKE A CLASS I OR II OR COLLECTION SYSTEM I OR II WASTEWATER EXAMINATION MAY DO SO BY PRE-REGISTERING FOR THE EXAM. PERSONS DESIRING TO TAKE A CLASS III OR IV WASTEWATER EXAM MUST HAVE TAKEN AND PASSED A CLASS II EXAM PRIOR TO ATTEMPTING THE CLASS III OR IV.** A photo ID (i.e. driver's license) must be presented before a test will be issued. Only writing instruments and a non-programmable calculator will be allowed in the testing area. All other materials will be provided.

Pre-registration fee for the wastewater certification classes (I, II, III, IV) for members of the Mississippi Water and Pollution Control Operators' Association, Inc. is \$250 and \$400.00 for non-members. Pre-registration fee for the CEU classes (water or wastewater) is \$200 for members and \$350 for non-members. These fees cover the cost of supplies, the lunch on Tuesday (tickets for the lunch will be \$20.00 for those not registered for the short course), and services related to the short course. The registration fee does not include manual fee, testing fee or expenses for lodging or meals.
